A preliminary deposit equivalent to 5% of Transaction Price shall be paid upon signing of the Preliminary Agreement for Sale and Purchase.

An extra 1% discount on the Price would be offered to the Purchasers who are Sino Club members.

(vi) 「Club Wheelock」會員優惠 Privilege for 「Club Wheelock」 member

買家如屬「Club Wheelock」會員，可獲額外1%售價折扣優惠。

An extra 1% discount on the Price would be offered to the Purchasers who are Club Wheelock members.

(vii) 「置業有禮」優惠 "Home Purchase" Discount

買方可獲額外1%售價折扣優惠作為「置業有禮」優惠。

An extra 1% discount on the Price would be offered to the Purchasers as the "Home Purchase" Discount.

- (d) 相關價單中可就購買該期數中的指明住宅物業而連帶獲得的任何贈品、財務優惠或利益
Any gift, or any financial advantage or benefit available with the purchase of a specified residential property in the Phase under the price list concerned

(i) 備用二按揭貸款(「第二按揭貸款」) Standby Second Mortgage Loan ("Second Mortgage Loan")

The Vendor is not, and will not be, involved in the arrangements of the Second Mortgage Loan. The Purchaser shall have no claims whatsoever against the Vendor as a result of or in connection with the approval and/or disapproval of the Second Mortgage Loan and/or any matters relating to the Second Mortgage Loan.

Notice is hereby given that the Vendor is not involved in the arrangement of the Second Mortgage Loan mentioned above. The arrangement of the Second Mortgage Loan is provided or procured to the Purchaser by the designated financing company and in no circumstances shall the Vendor be held liable for anything arising from or in connection with the arrangement of the Second Mortgage Loan.
